Information and Rules

Raffle Co-Sponsored By Fleming Oil and Brattleboro Savings and Loan

Rescue Inc. and the Windham County heat Fund, along with co-sponsors Fleming Oil and Brattleboro savings and Loan, are sponsoring a heating oil raffle. Proceeds of the raffle will be evenly distributed between the Rescue Inc. ambulance fund and the Windham County Heat Fund's supplemental heating assistance program.

We encourage people to purchase tickets early so that the drawing for the two grand prizes can be held well in advance of the coming heating season. The faster the tickets sell, the sooner the drawing will be held.

The delivery area is slightly limited although it covers almost all of Rescue Inc.'s service area. Please see the details below.

Tickets are \$10 each. A maximum of 1000 tickets will be sold.

The drawing will be held as soon as all tickets are sold or on September 7, 2009, whichever is earlier.

Two grand prizes of 250 gallons of #2 fuel oil will be awarded.
